CARDBOARD HELICOPTER PRIVACY POLICY

Last Updated on June 9th, 2022

This Privacy Policy (the "Policy") governs any and all data collection and usage by Company when You use Our Services and is designed to help inform you about the information Company may collect, who Cardboard Helicopter might share it with and how Cardboard Helicopter protects it. By using the Service, you acknowledge and agree to the collection and use of information in accordance with this Policy.

Interpretation and Definitions

All capitalized terms used herein and defined below shall have the meaning ascribed to them in the Policy. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions. For the purposes of this Policy:

Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Cardboard Helicopter, Inc., a product innovation company, with offices located at 2644 St Clair Ave. NE Cleveland, OH 44114.

Cookies means small files which are stored on Your web browser that hold a modest amount of data (including personally identifiable information), specific to You, mobile device, or any other device by a website, containing the details of Your browsing history on that website among its many uses.

Services means those online services provided to You by Company, including use of Our Website.

Personal Data is any information that relates to an identified or identifiable natural person.

Usage Data refers to data collected automatically, either generated using the Service or from the Service infrastructure itself (for example, the duration of a page visit).

You means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

Collecting and Using Your Personal Data

Types of Data Collected While using Our Service, Cardboard Helicopter may ask You to provide Us with certain personally identifiable information that can be used to contact or identify You. Personally, identifiable information may include, but is not limited to e-mail address; Your name or user name; contact information; demographic information; usage data; billing and payment data; and certain other data from You.

When You access the Service, Cardboard Helicopter may collect certain information automatically, including, but not limited to, the type of device You use, your devices unique ID, the Internet Protocol (IP) address, your operating system, the type of Internet browser You use, unique device identifiers and other diagnostic data.

Tracking Technologies and Cookies

You can instruct Your browser to refuse all Cookies or to indicate when a Cookie is being sent. However, if You do not accept Cookies, you may not be able to use some parts of our Service.

Cookies can be "Persistent" or "Session" Cookies. Persistent Cookies remain on your personal computer or mobile device when You go offline, while Session Cookies are deleted as soon as You close your web browser.

Use of Your Personal Data

The Company may use Personal Data: to provide and maintain Our Service; to manage Your account; for the performance of a contract; to contact You; and to provide You with news, special offers and general information about other goods, services and events which Cardboard Helicopter offers similar to those that You have already purchased or enquired about unless You have opted not to receive such information.

Cardboard Helicopter may share your personal information in the following situations: with Service Providers; for Business transfers; with Affiliates; with Business partners; and with other users.

Retention of Your Personal Data

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Policy, including to the extent necessary to comply with all applicable law, resolve disputes, defend against legal claims against Us, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes and to satisfy applicable legal requirements.

Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located, including on computers located outside of Your state, province, country, or other governmental jurisdiction where the applicable data protection laws may differ from those from Your jurisdiction.

YOUR CONSENT TO THIS POLICY FOLLOWED BY YOUR SUBMISSION OF SUCH INFORMATION REPRESENTS YOUR AGREEMENT TO THAT TRANSFER.

The Company will take those steps reasonably necessary to ensure that Your data is treated securely and in accordance with this Policy.

Disclosure of Your Personal Data

Business Transactions. If the Company is involved in a merger, acquisition or asset sale, Your Personal Data may be transferred as part of that transaction. Cardboard Helicopter will provide notice before Your Personal Data is transferred and becomes subject to a different Policy.

Law enforcement. Under certain circumstances, the Company may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g., a court or a government agency).

Other legal requirements. The Company may disclose Your Personal Data in the good faith belief that such action is necessary to: comply with a legal obligation; protect and defend the rights or property of the Company; prevent or investigate possible wrongdoing in connection with the Service; protect the personal safety of Users of the Service or the public; and Protect against legal liability

Security of Your Personal Data. The security of Your Personal Data is important to Us but no method of transmission over the Internet, or method of electronic storage is 100% secure. Cardboard Helicopter cannot guarantee its absolute security and by providing us with your Personal Data, you are waiving any claims of any kind or character against Us arising from or otherwise subject to this Policy.

Children's Privacy

Our Service does not address anyone under the age of 13. Cardboard Helicopter does not knowingly collect personally identifiable information from anyone under the age of 13. If You are a parent or guardian and You are aware that Your child has provided Us with Personal Data, please contact Us. If Cardboard Helicopter becomes aware that Cardboard Helicopter has collected Personal Data from anyone under the age of 13 without verification of parental consent, Cardboard Helicopter will comply with the Children's Online Privacy Protection Act, as the same may be amended from time-to-time.

Cardboard Helicopter also may limit how Cardboard Helicopter collects, uses, and stores some of the information of Users between 13 and 18 years old. In some cases, this means Cardboard Helicopter will be unable to provide certain functionality of the Service to these users.

If Cardboard Helicopter needs to rely on consent as a legal basis for processing Your information and Your country requires consent from a parent, Cardboard Helicopter may require Your parent's consent before Cardboard Helicopter collects and uses that information. Your Rights with Your Data

Depending on Your country of residence, you may have legal rights in Your data maintained by Us. These rights are subject to exceptions and limitations pursuant to applicable law, which may include Your right to: access Your data; correct Your data; erase Your data; and withdraw Your consent previously given to

process Your data.

These rights vary by location, and You may be able to exercise some of these rights by adjusting settings and "opting out" or "unsubscribing."
